#### 2. General

Planning application 39/23/00004 Construction of a temporary AIL bypass track and the erection of new gates was discussed. Comments/issues raised from the public included: how will this affect the environment, neighbours and people using the coastal path. The bypass will separate the path. There is no agreement/DCO for storage of AILs at the wharf. This is going to affect a lot of people especially those in Estuary Park. Can an environmental impact report be requested. Air quality is currently an issue and would get worse. The ideal place for AILs to be stored would be to the south of the ponds where the storage was originally proposed to be. The fencing that was installed around the wharf has made the noise worse for residents of Estuary Park as the sound bounces off the fencing.
